In accordance with section 27 of the Act, you have the right to complain to the Ombudsman for an investigation or review of the decision to refuse to supply the information to your request.

Hi Heather,

Absolutely acknowledge that you've been lenient with us and we appreciate that.

We'd obtained house moving quotes many months ago but ok only recently discovered separate work had to be commissioned for a draughtsperson to provide the paperwork required for council consent. This is the work we are currently having quoted. The quote received last week was not suitable unfortunately, and so we are fielding further quotes now, and asking they include advice on when the work can be completed.

Hi Austin and Tash,

Thank you, for coming back to me and apologies for the delay in my reply.

I think it best that I clarify our position following the recent enquiry regarding your compliance with condition 6 as stated below and following your comments regarding the quote for removal of the existing house.

6) The consent holder shall ensure that the existing dwelling shown on the approved plans shall:

• Be removed from the site within 6 months of first occupation of the new dwelling; and

• Photographic evidence of sufficient detail to demonstrate compliance with condition a) shall be provided to Council within 6 months

of first occupation of the new dwelling.

As I know you appreciate, we have extended a period of time for you to address the non-compliance as we have a level of discretion. Once enquires are made from the public about compliance with resource consent conditions we have a duty to respond/investigate and in cases where we are already dealing with matters of non-compliance re-consider our approach.

It is essential that this matter is quickly addressed since close to 6 months has now passed since you occupied your new dwelling. During this time, quotes could have be obtained for the removal.

I will brief our Team Leader, George Lewis but I would very much appreciate it if you could confirm where you are at regarding the acceptance of the quote.

Thank you for your prompt reply.

It is good to hear that you have a plan for the removal of the house. As the house has not been removed in compliance with the requirements of condition 6 of your above mentioned resource consent I will need to discuss this with the Monitoring and Compliance Team Leader and come back to you. Non-compliance with conditions of resource consent constitutes a breach of the Resource Management Act 1991, which is an infringeable offence.

You mention that title for the section you have purchased is waiting to be issued by KDC, this indicates that your section is most likely within a newish subdivision that is yet to have had approval of the survey plan and/or satisfy conditions of the subdivision consent.
