Hi Marie

Thank you for your official information request regarding gun clubs and firing ranges in Kaipara.

We are aware of two Clubs. The Northern Wairoa Gun Club is an outdoor facility and the Dargaville Pistol Club is an indoor facility. They are both located in the Dargaville area.

The Northern Wairoa Club has a vintage consent from 1979 or 1980 which was likely granted under the old Town and Country Planning Act.

The Dargaville Pistol Club does not require consent as its location is commercial zoned with ample parking available.

They operate outside normal 9.00 to 5.00 hours so parking and traffic has not been an issue. Should it become an issue Council would investigate.

Activities involving gun use do not feature in our Kaipara District Plan so both Clubs need to comply with Police licensing which includes gun safe regulations.

If a new gun club/firing range were to be proposed they would need to comply with our district plan rules on traffic intensity, parking, noise, lighting and glare and maybe other rules dependent on proposed location. There will be other safety and security requirements which are likely dealt with under Police and WorkSafe jurisdiction.

I trust this helps.


