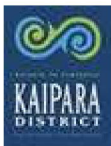
Sorry for the delay in responding.

1. Kaipara District Council received an application for the establishment of a poultry farm in Ruawai (RM180192). The application was received on the 29 June 2018 and was granted 6 September 2019.
2. Kaipara District Council received an application for a rural subdivision (RM180250) involving a boundary adjustment where the lots incorporated an existing poultry farm (free range egg chicken farm). Location was Maungaturoto. The application was received on the 5 July 2018 and was granted 18 September 2019.

Resource consents is not aware of any other resource consent applications for chicken/poultry related activities being establish, modified, expanding in the date range you have provided. The Kaipara District Plan is very permissive for rural activities and therefore many activities do not trigger breaches and the requirement for resource consent.

There have been no building consents issued for buildings relating to chicken farms from 1 July 2018 to March 2019

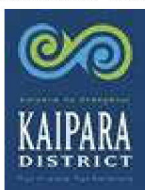
