# Kaipara District Licensing Committee Annual Report 2023- 2024 Introduction:

The purpose of this report is to inform the Alcohol Regulatory and Licensing Authority of the general activity and operation of the Kaipara District Licensing Committee for the period 01 July 2023 to 30 June 2024. The report is pursuant to s.19 of the Sale and Supply of Alcohol (Fees) Regulations 2013.


One District Licensing Committee (DLC) operates within the Kaipara District. The Council made the following appointments to form the new District Licensing Committee on Wednesday 29 July 2020.

During this reporting period a total of 205 applications have been determined by the DLC




Comparison of applications determined by the DLC Committee for the years 2021-2022, 2022-2023 and 2023-2024.



#### 1 Overview of the District Licensing Committees Workload

#### 1.1 Noticeable increase or decrease in the TA's business:


The number of applications received were similar with the number of applications determined by the Kaipara District Licensing Committee in the 2023-2024 year decreasing slightly in comparison with the previous year. The changes to the Act allowing a longer objection period may be a contributing factor to applications being carried over to the new financial year and therefore a decrease in applications determined by the DLC in the 2023- 2024 period. Two manager applications and an off-licence application were withdrawn (due to objections from agencies and the public) and did not proceed to the District Licensing Committee for their determination.



**Revenue:** The revenue paid to the Territorial Authority for application fees and annual fees continues to partly finance the inspectorate, administrative and committee components with regards to the preparing of all applications which must be determined by the District Licensing Committee.

A schedule of applications received is compiled monthly and sent to the Alcohol Regulatory and Licensing Authority (ARLA) in Wellington, together with a remittance to cover the proportion of fees due in terms of the Sale and Supply of Alcohol (Fees) Regulations SR 2013/452. Application and Annual fees payable to ARLA for the period 01 July 2023 to 30 June 2024 amounted to \$7935.00.


**DLC expenditure**: The Chair and members and associated costs for the 2023- 2024 financial year decreased in comparison with the previous year, however is expected to increase in the 2024-2025 financial year due to opposed applications received in the 2023 – 2024 year carrying over to the new financial year.




The alcohol licensing team continue to spend considerable time on the applications received by Council to ensure great customer experience is given whilst ensuring consistency and compliance with the Sale and Supply of Alcohol Act 2012 are maintained.

There are 70 licences granted to premises in the Kaipara District as of the 30 June 2024, compared with 72 as of 30 June 2023. On and Club licences remained the same with Off licenses decreasing by two.

Five premises have changed ownership during the year. Six premises ceased trading. As one door closes another one opens, and with the economic growth particularly in Mangawhai and Dargaville, new economic ventures are being explored. The Inspector is receiving enquiries regarding potential new premises within the Mangawhai and Dargaville areas and we are encouraging these types of proposed developments as best we can, including arranging on site meetings with new applicants and reporting agencies.





# 1.2 Agency meetings:

Meetings are usually held for the Kaipara Alcohol Accord on an as when required basis. These meetings are well supported by the licensees who have expressed their desire to continue to meet with agency representation. The meetings are held and hosted at alternating venues to allow maximum licensee attendance across the district. One Accord meeting was held in person in October 2023 and covered difficult customers and the trespass Act, training requirements, Northland Road Safety Trust and funding ideas, the licensed footprint and the upcoming Christmas season.

From the agency perspective, the Licensing Inspectors, Police, Medical Officer of Health and Fire Service (Kaipara Management of Alcohol Group representation) continue to work together collaboratively in satisfaction of s.295 of the Sale and Supply of Alcohol Act 2012. The agencies have implemented a policy of meeting with all prospective new licensees.

No Controlled Purchase Operations (CPO's) were carried out by the Medical Officer Health and the Police to test if licensees or their staff would sell to any minors. A planned CPO that was

cancelled (twice) earlier this year due to sickness of staff and volunteers has been rescheduled.

Compliance checks were conducted by Councils Environmental Health Officers to all licensed premises, with several unannounced visits to licensed premises by Kaipara's Licensing Inspector. (This included new operators and any premises that may be of concern.)

# 1.3 Noticeable trends or issues faced by the Territorial Authority:

Monitoring and policing the alcohol control areas is vital to ensure compliance with the recently amended Alcohol Control Bylaw adopted by Council on 31 July 2024. The Bylaw amendments were improvements around clause placement, formatting and grammar.

#### 2 Territorial Authority Initiatives

# 2.1 New initiatives adopted or tried by the Territorial Authority:

The Licensing Inspector and reporting agencies formally undertake to meet with any prospective new licensees. This includes both proposed new premises and changes in ownership of existing premises. This service aims to ensure that all prospective licensees fully comprehend the obligations and responsibilities under the Sale and Supply of Alcohol Act.

The Inspector has worked closely with licensees to ensure that they are carrying out regular ongoing training with their staff that is relevant to the Sale and Supply of Alcohol Act. A summary of this training is inputted into the Health Promotion Agencies tool kit folders provided to the licensees. The Territorial Authority obtains a copy of the premises managers registers; training records and incident logs at every alcohol inspection to ensure the licensee is adhering to the requirements of the Act.

The alcohol licensing team has worked collaboratively with Northland Road Safety Trust, with the Territorial Authority receiving funding of \$2300.00 to purchase 1500 key rings with a "Drive Sober" message. The keyrings were distributed to the licensees throughout Kaipara prior to the lead up to Christmas.



#### 3 Sale of Alcohol Policy – up to here.

#### 3.1 Sale of Alcohol Policy and when last reviewed:

Kaipara district does not have a Local Alcohol Policy (LAP). The Territorial Authority continues to successfully work closely with the Police, Ministry of Health, Fire Service and other agencies to provide a joint collaborative and consistent approach when reporting on applications.

(NB - For Council to consider the implementation of a LAP, there would need to be evidence based statistical data directly linked to alcohol related harm within Kaipara district. To date no evidence has proven conclusive to necessitate the progressing of a LAP for Kaipara district).

# 4 Enforcement and Inspections

### 4.1 Alcohol-related Bylaws:

As previously referred to, the Alcohol Control Bylaw 2018 was reviewed in 2024. Police are responsible for monitoring the alcohol control areas in Mangawhai, Dargaville, Ruawai, Kaihu, Aranga, Omamari, Baylys Beach, Glinks Gully, Pouto, Te Kopuru and Tinopai.

#### 4.2 Summary of inspections undertaken of licensed premises:

Compliance checks of licensed premises were undertaken by the warranted licensing inspectors. Licensed premises have been subject to inspections as and when required with the aim of visiting 100% of all licensed premises annually and this was achieved for the 2023-2024 year.

## 5 Liaison with Other Agency Groups

#### 5.1 Accord Liaison Group Meetings:

The Kaipara Alcohol Accord continues to meet, and the attendance is strong from a cross-selection of licensees across the district representing hotels, taverns, restaurants and clubs. The Territorial Authority continues to facilitate the meetings and to encourage customer driven creative ideas targeting the reduction in alcohol related harm within the community including updated and relevant signage for premises, T-shirts; key rings, hats or wallet holders promoting the Kaipara Accord group.

#### 5.2 Joint initiatives

The Inspectors continue to work closely with the Police, Public Health and the Fire Service in relation to inspections and any complaints lodged with the Territorial Authority. General checks for compliance are undertaken during both scheduled and impromptu visits to licensed premises. Joint agency / licensee meetings are held as required to resolve any issues of concern in a positive manner.

Police, Public Health, Fire Service and Inspectors from the Far North, Kaipara and Whangarei Council met in June 2024 to discuss common issues and strategies for reducing alcohol harm in Northland. It is envisaged that these meetings will be held quarterly.

#### 6 Statistical Information

The new structure to the Alcohol licensing team has greatly improved the customer experience, working closely with licensees, manager's and reporting agencies as and when required, this collaborative partnership has resulted in a successful relationship achieving what the Council requires whilst meeting its customer's needs.

From a chair's perspective the DLC is well served by staff during 2023/2024. We have arrived at an operating system for uncontested applications which is low key, effective and efficient.
