Appointment of Chair to the Harding Park and Pou Tu Te Rangi Joint Management Committee

Section 33(5) of the Te Uri o Hau Settlement Act 2002 requires that:

- (5) Despite subsection (3), the Minister of Conservation must
 - (a) appoint a joint administering body for Pou Tu o Te Rangi comprising 3 persons nominated by Te Uri o Hau governance entity and 3 persons nominated by the Kaipara District Council; and
 - (b) appoint one of the 3 persons appointed by Te Uri o Hau governance entity as chairperson of the joint administering body and with a casting vote.'

This 'Pou Tu o Te Rangi Joint Management Committee' was established by the Minister of Conservation on 03 July 2006 comprising three members nominated by Council and three nominated by Te Uri o Hau.

At its 20 September 2017 meeting, the Harding Park and Pou Tu Te Rangi Joint Management Committee was asked to select a Chairman. Rex Nathan and Willie Wright were nominated by Hal Harding and seconded by Karen Joyce-Paki.

The Harding Park and Pou Tu Te Rangi Joint Management Committee then resolved that: *...the Harding Park and Pou Tu Te Rangi Joint Management Committee be co-chaired in tandem by Messrs Rex Nathan and Willie Wright.*[']

A copyⁱ of the full minutes is included with this letter for your reference.

In light of the above, it is requested that the Minister of Conservation formally appoint Rex Nathan and Willie Wright to be the Co-Chairs of the Harding Park and Pou Tu Te Rangi Joint Management Committee and with casting votes. Rex Nathan and Willie Wright are two of the three persons



appointed by Te Uri o Hau governance entity to be a member of the Pou Tu Te Rangi Joint Management Committee.

Summary

The Harding Park Committee has been established to work alongside the Pou Tu Te Rangi Joint Management Committee to implement the adopted 2002 Pou Tu Te Rangi and Harding Park Reserve Management Plan (RMP).

There is a \$100,000 capital works budget available in 2017/2018 to implement the Works Programme that was approved in September 2017.

The Traffic Report signage has been installed and the roadmarking has been completed.

The Roading Engineer has been asked to check the feasibility of a "Bypass".

I would also like to make a recommendation that we reduce the number of Harding Park Committee and Pou Tu Te Rangi Joint Management Committee meetings to two meetings per year as per the Terms of Reference (Attachment 1).

Recommendation

That the Harding Park Committee and Pou Tu Te Rangi Joint Management Committee:

- 1 Receives the Parks and Community Manager's report 'Operations Update: October/November 2017' dated 08 November 2017 and the information contained therein; and
- 2 Believes it has complied with the decision-making provisions of the Local Government Act 2002 to the extent necessary in relation to this decision; and in accordance with the provision of s79 of the Act determines that it does not require further information prior to making a decision on this matter; and

Reason for recommendation

This will keep the Committee up-to-date on progress and relevant information regarding the ongoing operations and implementation of the Pou Tu Te Rangi and Harding Park Reserve Management Plan.



Reason for the report

To report on the operations by providing an update for the October to November 2017 period and the 2017/2018 Works Programme.

Background

The Harding Park Committee and Pou Tu Te Rangi Joint Management Committee (the Committee) is charged with implementing the July 2012 Pou Tu Te Rangi and Harding Park Reserve Management Plan (RMP).

The adoption of the RMP signals the start of a new phase for this site and its wider surrounds. It is intended that any future development or land use decisions must recognise the RMP's shared vision/goals for Harding Park and Pou Tu Te Rangi Pa (Park and Pa site).

Operations update

Council has approved \$100,000 per annum capital works per annum and the Committee adopted the 2017/2018 Works Programme in September 2017.

General matters

The Traffic Report signage has been installed and the roadmarking has been completed.

The KDC Roading Engineer has been asked to check the feasibility of a "Bypass". This was discussed at the last meeting. It was thought that there could be a bypass road below the Museum for when there are functions at the Lighthouse Function Centre. The Roading Engineer will look at the options and give an estimate of costs to help the Committee make a decision around this.

Discussions have started with a Landscape Architect with regards to the look and feel of the park and what future buildings, etcetera, will look like.

The recommendation to reduce the number of Harding Park Committee and Pou Tu Te Rangi Joint Management Committee meetings to two meetings per year is to align with the Terms of Reference (Attachment 1).

Factors to consider

Community views

The RMP was developed using a public process and reflects the views of the community and other stakeholders at the time of its development. The Park and Pa site is popular with local and visitors to the area. The site, particularly the Museum, is considered to be amongst Dargaville's greatest attractions. Public interest in any decision relating to governance of this area is therefore high.

Policy implications

There are no policy implications as all recommendations are consistent with the RMP.

Financial implications

It is the Parks and Community Manager's responsibility to ensure all operations are conducted within budget. The financial budgets are set within the Long Term Plan and respective Annual Plan.

Legal/delegation implications

There are no delegation issues; the Harding Park Committee has delegated authority from Council to govern Harding Park in accordance with its Terms of Reference.

Assessment of significance

This is not a significant activity on Harding Park and as such is not considered to be significant in terms of Council's Significance and Engagement Policy.

Next step

Implement the approved 2017/2018 Works Programme and continue to maintain the developments undertaken to date.

Resend the appointments for the two Harding Park Committee and Pou Tu Te Rangi Joint Management Committee meetings next year.

Purpose

To work alongside the Pou Tu Te Rangi Joint Management Committee to manage the Pou Tu Te Rangi, Harding Park and Old Mount Wesley Cemetery Reserve

Responsibilities

Implementing the Reserve Management Plan;

Managing any financial resources of the Reserve;

- Managing and maintaining any licences to occupy in accordance with the Reserve Management Plan;
- Setting the Annual Works Programme;

Meeting as a Joint Committee with the Pou Tu Te Rangi Joint Management Committee

Delegations

 The Committee makes recommendations to the full Council for any policies or developments required;

Administering any bylaw or regulation associated with the Park.

Membership

The membership of the Harding Park Committee is the same the members of the Pou Tu Te Rangi Joint Management Committee. The membership is three members nominated by Te Uri o Hau Settlement Trust and three appointed by Kaipara District Council, of which two must be Councillors

- The Chair of the Harding Park Committee will be the same as the Chair of the Pou Tu Te Rangi Joint Management Committee and must be one of the Te Uri o Hau appointees.
- Membership will be reviewed after each triennial election.

Communications

- The Committee Chair is the authorised spokesperson for the Committee in all matters where the Committee has a particular interest;
- Committee members, including the Chair, do not have delegated authority to speak to the media on behalf of Council on matters outside the Committee's interest;
- Council's Corporate Services department will manage and support formal communications between the Committee and Council, and for the Committee in the exercise of its business.



Conduct

The Committee shall conduct its affairs in accordance with the Local Government Act 2002, the Local Government Official Information and Meetings Act 1987, the Local Authorities (Members Interest) Act 1968 and Kaipara District Council's Standing Orders and Code of Conduct.

Remuneration

Elected members will be reimbursed in accordance with the determination set by the Remuneration Authority under section 255(5) and Clause 18 of Schedule 15 of the Local Government Act 2002 and Council's Current Elected Members Expenses Policy.

Funding and budgets

Funding for the Committee will align with the Council's Annual and Long Term Plans
