Council will be asked to make a decision at a Council meeting, unfortunately I do not know when that will be. Very soon, I hope.

Council has not yet done the studies that are identified in the NPS UD although population and economic studies are undertaken by Infometrics.

I know that a new Infometrics report will be presented to Council soon on the latest population and economic data.

When the District Plan Review has progressed to the Proposed stage, capacity studies will become available, but we are not there yet.

To assist with our submissions on PPC 82, there is some evidential information which I would appreciate having disclosed:

- (1) Could you arrange to be emailed to me please Council's quarterly monitoring information for the Dargaville Urban region as provided for under s3.9 of the National Policy Statement on Urban Development. (Tier 3 local authorities are required to undertake monitoring so I would expect this information to be reasonably available)
- (2) Can you also provide me with a copy of the evidence based assessment completed by Council on the demand for development capacity required by s3.11 National Policy Statement on Urban Development (including the relevant Housing and Business Development Capacity Assessment required by subpart 5 of Part 3).
