- The applicants do understand that they have to pay some contribution and have offered to pay the roading contribution.
- Officers initially gave incorrect advice.

- MCWWS Advisory Panel has completed a meeting with the Golf Club. General support for use of the Golf Club for disposal.
- Of those with outstanding rate arrears that Council has filed Court documents on,
   41 property owners have lodged a Statement of Defence (of whom 11 have paid).
- Another 20 have not paid but have not put in a Statement of Defence
- Still no Parks monthly report. New Parks Manager is to start shortly so these should restart following that.
- Consent numbers are still high in the east of the District. Growth has been consistently high for nearly two years.
- Have increased proactive enforcement in planning area.



Need to do an exercise to evaluate the projected margins on forestry. However
alternative uses for these blocks of land are limited. No extensive review has been done.
In the past replanting has been automatic. It would be appropriate to do the review
before replanting.
