Mangawhai Activity Zone Charitable Trust – Variation of Licence to Occupy

1 Purpose/Ngā hāinga

Council has been approached by the Mangawhai Activity Zone Charitable Trust (the Trust) for a variation to their Licence to Occupy (LTO) for the purpose of a pump track, and small takeaway café. The Mangawhai Community Park Governance Committee (the Committee) does not have delegated authority to vary the LTO but can recommend to Council if they support the application. Council is unlikely to grant a variation without the Committee's approval.

2 Recommendation/Ngā tūtohunga

That Mangawhai Community Park Governance Committee:

- a) Supports a variation of the Mangawhai Activity Zone Charitable Trust's Licence to Occupy to extend the lease area to provide for a proposed pump track, as shown in Attachment B appended to this report, and to allow for the operation of a small takeaway café
- b) Recommends to Council to approve a variation of the Mangawhai Activity Zone
 Charitable Trust's Licence to Occupy to extend the lease area to provide for a proposed
 pump track, as shown in Attachment B appended to this report, and to allow for the
 operation of a small takeaway café.

3 Executive summary/Whakarāpopototanga

The current LTO signed with the Trust in 2016 is for an area of 1.679 hectares of the Mangawhai Community Park (the Park) for a period of 30 years. The Trust has asked that a variation to their current LTO be granted to include land for a pump track proposed to be

placed on land behind where St Johns Ambulance is located at the Park (refer **Attachment B**), and for the inclusion of a small takeaway café operation.

The area sought for the pump track is approximately 1,000 square metres and the Trust has currently received a donation of \$30,000 for this project. A pump track would complement the existing activities at Mangawhai Activity Zone.

Council sought a legal opinion on whether a café operation would be covered in the current LTO. The opinion received suggested that the Trust's current LTO does not cover commercial activities, such as a takeaway café.

4 Discussion/Ngā kōrerorero

4.1 Options/Ngā kōwhiringa

A. Grant a variation of the current LTO to the Trust for the purpose of a pump track located behind St Johns Ambulance base at the park, and for the inclusion of a commercial activity being a small takeaway café. Staff have talked to St Johns Ambulance in Mangawhai who have no objection in principle to the pump track. St Johns will look to approach the Trust for an agreement between the two parties in relation to matters of mutual interest. Friends of Mangawhai Community Park also agree with the proposal and staff await confirmation in writing of this.

Conditions of approval to include a small takeaway café would include compliance with all health and food regulations, and adequate provision of recycling and refuse disposal facilities to minimise the risk of litter as a result of the operation.

This is the recommended option.

- B. Ask the Trust to locate the proposed pump track within land currently covered in their LTO and grant the inclusion of a commercial activity being a small café. The Committee may wish for the Trust to utilise land currently contained within their LTO for the purpose of a pump track but feel that a small takeaway café may enhance activities currently located at the site.
- C. Grant a variation of the current LTO to the Trust for the purpose of a pump track but decline the small takeaway café operation. The Committee may feel that a pump track complements existing activities but that a commercial takeaway café does not.
- D. Decline the variation of LTO to the Trust for the pump track and small takeaway café.

4.2 Financial implications/Ngā ahumoni hīraunga

If approved this decision will not have any financial implications for Council. Funding for the pump track will be sourced by MAZ through external providers (**Attachment A**).

4.3 Policy and planning implications/Kaupapa here me hoahoa hīraunga

The Mangawhai Community Park Master Plan (the Plan) has been read in conjunction with the writing of this report.

The vision of the Plan is for public space used for recreation and enjoyment of the outdoor environment. A pump track would be in line with this vision.

The current and future uses of the Park objectives state that commercial uses will not generally be allowed, unless they are secondary to the non-commercial use principle for the intent of fundraising, attracting visitors and the like. It can be argued that a small takeaway café would attract more than deter visitors to the facility, and would complement the Park's use.

4.4 Risk/Ngā tūraru

No known risks or issues have been identified as part of this report.

5 Significance and engagement/Hirahira me ngā whakapāpā

The decisions or matters of this report do not trigger the significance criteria outlined in Council's Significance and Engagement Policy, and the public will be informed via the agenda on the website.

6 Next steps/E whaiake nei

Council will receive the Committee's recommendation and make the final decision at the next Council meeting on 28 February 2019. If Council approves the variation to the LTO, the Trust will manage the process in regards to the construction of the pump track and the appointment of the contractor for the takeaway café.



Mangawhai Community Park Master Plan Operations Update - November 2018 to December 2018

1 Purpose/Ngā hāinga

To report on the Master Plan operations, providing an update for the November 2018 to December 2018 period.

2 Recommendation/Ngā tūtohunga

That Mangawhai Community Park Governance Committee notes the Parks and Recreation Manager's report 'Mangawhai Community Park Master Plan Operations Update - November 2018 to December 2018'.

3 Executive summary/Whakarāpopototanga

The Mangawhai Community Park Governance Committee (MCPGC) is the body which oversees the implementation of the Mangawhai Community Park Master Plan (the Master Plan) for the Mangawhai Community Park (MCP). The revised MCP 2015/2025 Work Programme was adopted in June 2016 and amended in May 2017.

A summary of activities, operations and maintenance work carried out over the months of November 2018 to December 2018 is reported below.

4 Context/Horopaki

The Master Plan was developed after public consultation and feedback and adopted by Council on 25 November 2014. The Vision for the Park is:

Mangawhai Community Park will be a visible, predominantly natural, public space at the entrance to Mangawhai Heads, used (freely) by the community for recreation and enjoyment of the outdoor environment.

5 Discussion/Ngā korerorero

The following is a summary of activities, operations and maintenance work carried out over the months of November 2018 to December 2018:

- Staff have continued working on the Resource Consent for the vegetation clearance
 and working near wetlands to create the service lanes and have had a pre application
 meeting at the KDC office in Mangawhai. We are now arranging an onsite meeting
 with Council's Ecologist to look at the site and discuss options.
- Site survey plan is complete at this stage until we have had our onsite resource consent pre application meeting.
- The Museum surrender of lease is still on going with discussions being had regarding bus access and location of the Arts building.
- Pioneer Village building refurbishments are continuing with the Tara School and Old Post Office now complete.
