






Hi Lynda and Gary,

Confirming the changes to the branding posts: Maori post:

- 1. The edging of the Tunatahi and elvers to be a greeny-gold. I thinks it's a gold colour at present.
- 2. The design is to be repeated on the back of the post.
- 3. The eel is to curl around the post slightly rather than straight up the post as is depicted at present. Maritime Post:
 - 1. The rope is to be tightly wrapped around the post with no gap shown, just above the top of the anchor... about 200mmm from top of anchor to bottom of rope approx..
 - 2. An circular image of a sailing ship and a waka, which I will supply, is to be inserted into post at about eye level, Gary to use his eye to make the final decision where this should sit on the post, to ensure this looks OK..
 - 3. The three images to be repeated on the back of the post.
 - 4. The Longitude and Latitude of the post is to also put on this post. Under the word Maritime.

Pioneer Post:

- 1. The dancing images have been approved
- 2. There will need to be Dalmatian (Kola dancers), Polish; Dutch; French; Greek; Chinese; Russian; Italian; Irish; English; Scottish; Maori Poi dancers. **12 circles in total** and these are to be spread around the post so to see all images you would have to walk around it. If these do not all fit come back to me and I will look at deleted the least important ones.

I do understand there will be extra charges on top of the original quote.

Summary

The Harding Park Committee has been established to work alongside the Pou Tu Te Rangi Joint Management Committee to implement the adopted 2002 Pou Tu Te Rangi and Harding Park Reserve Management Plan (RMP).

There is a \$100,000 capital works budget available in 2017/2018 to implement the Works Programme that was approved in September 2017.

A summary of activities, operations and maintenance work carried out over the months of March 2018 to May 2018 is reported below.

Recommendation

That the Harding Park Committee and Pou Tu Te Rangi Joint Management Committee:

- 1 Receives the Parks and Recreation Manager's report 'Operations Update: March 2018 May 2018' dated 23 May 2018 and the information contained therein; and
- 2 Determines that it believes it has complied with the decision-making provisions of the Local Government Act 2002 to the extent necessary in relation to this decision; and in accordance with the provision of s79 of the Act determines that it does not require further information prior to making a decision on this matter; and
- 3 Accepts the Dargaville Dalmatian Cultural Club Inc's invitation to the '160 Year Celebration of First Dalmatian Immigrant Arrival in New Zealand', on Saturday 10 November 2018 at Harding Park, and nominates _____, and _____ as the alternate, to attend and give a speech as representative of the Harding Park and Pou Tu Te Rangi Joint Management Committee.

Reason for recommendation

This will keep the Committee up-to-date on progress and relevant information regarding the ongoing operations and implementation of the Pou Tu Te Rangi and Harding Park Reserve Management Plan.

Reason for the report

To report on the operations by providing an update for the March 2018 - May 2018 period and the 2017/2018 Works Programme.



Background

The Harding Park and Pou Tu Te Rangi Joint Management Committee (the Committee) is charged with implementing the July 2012 Pou Tu Te Rangi and Harding Park Reserve Management Plan (RMP).

The adoption of the RMP signals the start of a new phase for this site and its wider surrounds. It is intended that any future development or land use decisions must recognise the RMP's shared vision/goals for Harding Park and Pou Tu Te Rangi Pa (Park and Pa site).

Operations update

Council has approved \$100,000 per annum capital works and the Committee adopted the 2017/2018 Works Programme in September 2017.

General matters

Local Rotary has done a planting in conjunction with the Dargaville Primary School on the lower slopes of the park near the old Mt Wesley Cemetery. The plants were Manuka and paid for from the budget.

Due to the possibility of external funding, the landscape design has been put on hold and the budget used to progress the vegetation removal and planting. The two gully areas and the remaining trees along the road frontage are programmed for removal. The remaining Manuka will be planted shortly and the existing new plantings are being maintained.

We are still waiting for the quote for the Lighthouse Function Centre verandah's shade sails.

A letter has been received from Dargaville Dalmatian Cultural Club informing the Committee of the '160 Year Celebration of First Dalmatian Immigrant Arrival in New Zealand' to be held at Harding Park on Saturday 10 November 2018 (Attachment 1). The Club has invited a Committee representative to attend and give a speech and also seeks guidance from the Committee on who best to approach regarding their wish for a kaumātua to give a blessing on the day.

Factors to consider

Community views

The RMP was developed using a public process and reflects the views of the community and other stakeholders at the time of its development. The Park and Pa site are popular with locals and visitors to the area, and are considered to be amongst Dargaville's greatest attractions. Public interest in any decision relating to governance of this area is therefore high.

Policy implications

There are no policy implications as all recommendations are consistent with the RMP.

Financial implications

It is the Parks and Recreation Manager's responsibility to ensure all operations are conducted within budget. The financial budgets are set within the Long Term Plan and respective Annual Plans.

Legal/delegation implications

There are no delegation issues: the Harding Park Committee has delegated authority from Council to govern Harding Park in accordance with its Terms of Reference.

Assessment of significance

This is not a significant activity on Harding Park and as such is not considered to be significant in terms of Council's Significance and Engagement Policy.

Next step

Implement the approved 2017/2018 Works Programme and continue to maintain the developments undertaken to date.

160 Year Celebration of First Dalmatian Immigrant Arrival in New Zealand10 November 2018 at Harding Park

The Dargaville Dalmatian Cultural Club wishes to inform the Harding Park Pou Tu Te Rangi Committee of an event we are organising at Harding Park. We are hosting a celebration of 160 years since the first Dalmatian immigrant settled in New Zealand. This event is planned to be held in Harding Park on Saturday 10 November 2018. The day will be a celebration of the contribution of the Dalmatian people and culture in Northland and NZ. The Dalmatian Clubs of Kaitaia, Whangarei and Auckland are also involved and will be attending. The day will involve traditional dance and singing by the clubs' groups, kai, displays, speeches, and access to both the Museum and the Vintage Machinery Club. The event will be open to the public with a ticket price of \$25 (kai included) or \$15 (no kai). We have been in discussion with the Dargaville Museum and the Vintage Machinery Club, both are supportive and are participating in the day. We have also been in discussion with Council's Park Officer.

We would like to invite a representative of the Park Committee to attend the day, and, if they wish, to give a speech.

We also seek a blessing to be given on the day by a kaumatua. We seek guidance from the Park Committee on who best to approach about this.

Given the close relationship between the Dalmatian and Maori cultures and people, we would like there to be a kapa haka performance at the event and wish to invite the Te Kopuru Primary School group.

I am happy to attend the Park Committee's next meeting on 6 June 2018 to elaborate on this letter.
